- 6. Acknowledge that in the event of a breach of any By-law relation to pets the Owners Corporation may withdraw any consent it has given me for the keeping of a pet.
- 7. I understand that it is the responsibility of the pet owners to monitor the noise from pets. Be mindful of neighbours.
- 8. I understand approval is only provided with the understanding that:
 - The dog must be kept on leash the entire time whilst anywhere on common property and is properly restrained and not allowed to jump or interfere with other residents who may be fearful or nervous of dogs
 - All droppings, litter and pet food residues must be well bagged and taken directly to the Bin Room and not dropped in corridor floor Garbage Chutes
 - Dog droppings outside and around building must be cleaned up and disposed of thoughtfully by the owners
 - Any mess caused by the pet on common property is the responsibility of the owner to
